# DAISY Award Nomination Criteria Qualifications/Eligibility

- Any Registered Nurse who has been employed by Bradley Hospital for the past 6 months and currently practices in a clinical patient care setting.
- Obtains an excellent performance evaluation by nurse manager/supervisor.

The DAISY criterion incorporates the IOM six aims of safety, patient-centeredness, effectiveness, efficiency, timeliness, and equity. These aims have been embraced by Bradley Hospital to ensure the best care possible.

# Must exemplify at least three of the following criteria:

- Demonstrates the importance of communication in the delivery of quality and safe patient care as evident by active assertive communication and patient advocacy with colleagues on the interdisciplinary team.
- Demonstrates commitment to the development and implementation of organizational goals, priorities, and strategies as evidenced by Committee,

- council, or project involvement.
- Promotes safety and quality patient care by contributing to committees at the local, state, and or national level.
- Implements current evidence based practice by researching best practices, developing policy based on these, and developing educational material for patients & families, and/or colleagues.
- Promotes, designs, develops, and implements patient safety and quality initiatives or programs such as assuring that restraint/seclusion are never used unless all other measures have failed.
- Initiates or participates in research directed toward advancement of clinical practice and nurses sensitive outcomes of care.
- Demonstrates excellence in the delivery of individualized patient care based on knowledge, expertise, and development of relationships with patients and families that promote trust and are healing in nature.
- Advocates for patients and families by participation in professional organizations, local, state, and/or national initiatives, boards, etc.

Criteria and qualification will be validated by the DAISY Council. Winner will be selected by the DAISY Council.
